### Call to Order

SAA First Vice President, Vicky Velasco, called the meeting to order at 6:22pm.

# **Guest Speaker**

Velasco welcomed Gregory Prastacos, Dean of the Stevens School of Business. Prastacos shared the latest news, accolades, and achievements of the Stevens School of Business. He remarked on the tremendous progress that has been made over the last five years and highlighted key milestones achieved. Most notably, he commented on the fact that not only is the Stevens School of Business now accredited, but that many of its faculty members are being published in top journals.

# <u>President's Report</u>

Velasco introduced Seth Kirschner, a student leader involved with StevensTHON. Kirschner presented information concerning the second annual StevensTHON, a fundraising event led by students. Velasco then had the other student guests stand up and introduce themselves to the Association members present.

Velasco asked Melissa Fuest, Assistant Vice President of Alumni Engagement and Annual Giving, whether there was a quorum of the Executive Committee present. Fuest confirmed that there was a quorum: six members of the SAA Executive Committee were present.

She then stated the purpose of the SAA: *The Stevens Alumni Association is formed to establish, maintain, and cultivate among its members a sentiment of regard for one another and of attachment to Stevens Institute of Technology, and to promote in every way the interests of the institute.* 

**RESOLUTION:** To approve the minutes from the February 13, 2017, meeting of the Executive Committee.

Motion – Peter Astor; Seconded – Leslie Brunell; Discussion – none; Vote – unanimous. Velasco provided the Executive Committee with an update on the status of the draft of the new constitution. She noted that the appointed Constitution and Bylaws Committee of the Stevens Alumni Association had been meeting weekly and would continue to do so. She also shared that the Committee would be seeking input from individuals in the coming weeks.

### **Committee Reports**

Clubs Committee

Keith Cassidy shared the *SAA Clubs Committee Operations and Goals* document. He noted that individuals wanting to review the document in more detail may contact him directly for the document.

Keith also shared that the Dramtic Society Alumni Affinity Club had an event scheduled for April 8, and that the Stevens Metropolitan Club had an event on March 23. Finally, Keith noted that they were in talks with Alpha Phi Omega alumni to begin forming an official club.

Graduate Representative (two-year term): John Tracy '65

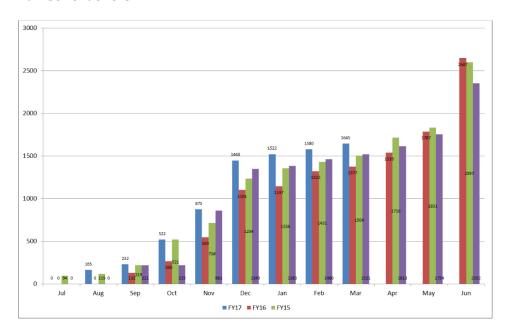
